

## XTREAMS TOOLKIT UI DEVELOPMENT ON MICROSOFT WINDOWS PRESENTATION FOUNDATION TECHNOLOGY

### ABSTRACT

This project is a software application that runs with the station controller. When an error appears at the station controller it triggers a response flow checklist (RFC). An RFC is a troubleshooting procedure that helps you fix problems in manufacturing. A RFC is a series of instructions you define to help a manufacturing technician troubleshoot an equipment-related problem while processing. Trigger is a combination of micro-conditions. When a trigger occurs XTREAMS system automatically, it retrieves the RFC associated with that trigger. Authoring is the process of creating RFCs using the XTREAMS authoring tool. One can use the XTREAMS authoring tool to create RFC flow diagrams that the XTREAMS execution tool will display as step-by-step instructions for the RFC user. During running of a tool if the equipment is not ok, there could be multiple reasons or causes (C1, C2). These causes could be isolated by running a pre-defined checklist, that is, RFC. After the RFC and the triggers that are associated are approved using the XTREAMS Authoring Application the contents are send over to the various Intel Sites which are XTREAMS enabled. The toolkit that is provided with XTREAMS product provides one a unique capability to translate the received RFC contents to geo-specific languages so that the RFCs are relevant for the users of that particular geo. The aim here is the XTREAMS toolkit UI development on Microsoft Windows Presentation Foundation Technology so as to make it even more efficient and reliable, also which will set it free for unit tests to be performed appropriately. The MVVM framework has been followed for the purpose of development.

WPF is a next-generation presentation system for building Windows client applications with visually stunning user experience. It is a graphical subsystem for rendering user interfaces in Windows-based applications by Microsoft. A wide range of both standalone and browser-hosted applications can be created using WPF. The core of WPF is a resolution-independent and vector-based rendering engine that is built to take advantage of modern graphics hardware. WPF extends the core with a comprehensive set of application development features that include extensible application markup language (XAML), controls, data binding, layout, 2-D and 3-D graphics, animation, styles, templates, documents, media, text, and typography. WPF is included in the Microsoft .NET framework and can be used to build applications that incorporate other elements of the .NET framework class library. Following the success of markup languages for web development, WPF introduces XAML, which is based on XML. XAML is designed as a more efficient method of developing application user interfaces.

### LOGGING

The steps of execution and the errors that are encountered are recorded in the log files.

Some of the events logged are:

- The user's IDSID and the role request
- The status of connection establishment with the Docbase
- Status of the group requested
- Status of the groups in configuration file
- Status of the user in the docbase
- The status of the format of the request
- The success or failure of the operation (add or delete)
- The format of the name in the docbase
- There are in totality five log files - each for every application (VFA, SAMS, LCAD, and XTREAMS) and an additional main log

"RialtoService.log" which corresponds to the overall service like if the application logger has been configured or not.

In case of a new user request, if the user is not present already in the Docbase, a new user is created using the credentials retrieved from the CDIS.

The service maintains a request table "app\_rialto\_roles" which records the request for each role against the user name whose purpose is to keep a check on the requests the particular user has made.

- Add user role

### MOVING VERTICAL TEXT RECOGNITION TECHNIQUE

Most of the test tools can easily capture normal text in combo box, text box, or even text in images (Bitmaps). For horizontal text capturing, there are lots of methods including get visible text method (this method name is available in unified functional testing (UFT) in other tools method name changes but working remains same), Get RO property method (i.e., Text can be found in object repository), etc., but when it comes to find vertical text all these methods failed. If the text is fixed at one point, then using text area output, it is possible to find out text at that particular point. However, that method is also not useful because output of that text in message box will be in horizontal form so it will be very difficult to store that text into any string. Fig. 1 shows the exact problem of vertical text recognition. Text special is in vertically arranged fashion and its output from get visible text is also shown beside it which is incorrect. As seen in the output, graphical user interface (GUI) test

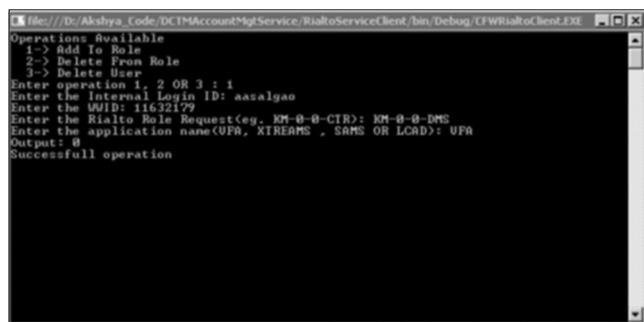

detects text in the image, but as text is not in required format, the tool fails to capture exact text. This problem can be eliminated by capturing a bitmap of image that contained text then using script to convert that bitmap into needed form (i.e., Using a method to rotate the image) then captures text using get visible text method. Bitmap capture is one of the important features of any testing software but capturing only needed part of bitmap and saving then has to be scripted. After saving bitmap containing only text can be open in script and made to be in required format. Vertical text recognition: Get visible text captured data implementation. Vertical text in an application with its text area output is shown which will give details about problem in direct method. Hence, to overcome, this problem first required bitmap is taken from the application using bitmap checkpoint and that bitmap is saved in one location. This bitmap is then called again in the script by creating object for that bitmap (using create object method). Then using rotation technique and making that bitmap in required horizontal form so that get visible text will give required text. Vertical text recognition: Bitmap checkpoint. ### FINDING PART OF TEXT FOR WINDOWS BASED APPLICATION

The disadvantage of having Windows-based application in our hand is that automation tools may or may not recognize objects on the application, but even if they do, tools provide very little information regarding that object. Much of the time, they are not able to recognize text written in that object. Hence, the tool gives separate text recognition technique which can be used to detect all text displayed on that object (UFT uses OCR technique to detect text). This kind of methods works perfectly on WPF objects but when it comes to win object method may detect text with random characters. Even if it did recognize text correctly, it is important to find only required text and eliminate unnecessary text. Example - in the code first line - where get RO property method is used gives value in edit box but when unit text is required (in this example special) tool does not detect unit as separate box, but it detects whole as win object. In the property of this win object, there is no property to find unit text. As UFT provides a method to acquire text from an object which gives all text from that object so to capture the particular text, there are more than one way. The simplest one is that we can separate text using split method by giving a string as an expression and (blank space) as delimiter. This will give each word in the string so then we can select necessary text that we need. Another method is using scripting techniques which find length of text in win edit and win object using the Len method than using Trim method one can eliminate unnecessary text. Then using Instr and right method, one can find required text: Get visible text method for win edit box. Get visible text method for win object.

### WORKING WITH EXCEL AND DATA TABLE

Automation tools including UFT come with data table which are similar to excel. Excel always has a greater advantage in storing data in table format so it becomes an important factor whenever one uses data table. Excel is one of the useful parameters for importing and exporting data. It gives greater advantage and ease if one want to import data for automation tool as most of the tools have direct command for importing and exporting excel through data table considering already excel data is stored in your computer. However, script gets tricky when excel need to get created from tool only and import it into data table. Implementation - excel can be created in UFT using the create object method. After creating excel file better approach is to import that excel file into UFT data table using import method because UFT provide lots of simplified methods for data table than excel object. There is method called AddParameter in get sheet to give column name for particular column which helps to import only required data in required column. Taking data into data table are very useful because of extensive methods and simple method to import and export data.

### FINDING USEFUL DATA IN EXCEL DYNAMICALLY

Even if all data are present in data table, most of the time, it is necessary to find only particular value from data table and use it in data driven script. Most of the scripting languages do not provide direct method for it so it has to be scripted and script has to be in such a way that it cannot directly point to data (i.e., Giving directly row and column name in script is not good approach) and better approach is to find the data within whole data table. Sometime, it is required to find one particular column data and give its value as input to textbox one by one. Hence, the simple technique is to copy that column data one by one till the null value; using looping techniques which will work till null is arrived and then put that value in the required text box or as necessity of logic. Implementation - As UFT does not support many of the methods for excel compared to data table so it is better to import all data into data table then sorting can be done on that data. After importing, required value can store in an industrial research on GUI Testing Techniques for Windows based Application using UFT 469 variable to check with each cell value in data table. Using nested if statement, one can check for all values till null arrives code.
